## **Dear Catholic School Families:**

May God's peace be with you. This afternoon, Governor Baker extended the suspension of all public and private PK-12 schools in the Commonwealth of Massachusetts until May 4, 2020. After Governor Baker's first declaration, the Catholic schools of the Diocese of Springfield transitioned to remote learning. At that time, we hoped that we would return to school in early April. Knowing this was doubtful, we created remote learning guidelines and resources to ensure our schools continue to provide a high quality education in the event of an extended suspension. The principals of the schools and the Catholic Schools Office are meeting this Friday to discuss this plan and identify the support necessary for full implementation. The Catholic Schools Office will continue to monitor the State's response to this situation and recommend action based on any new information or mandates.

At this point, remote learning will continue until May 4, 2020. Your school leaders will communicate with families additional directives, resources, and support that ensure your children are learning at home in the most reasonable and anxiety free manner. If the mode of delivery from your school is difficult to sustain due to a lack of resources or other restrictions, please contact your principal to discuss ways to ensure that your children continue learning at home effectively.
